Candidates

The competition is open to dental technicians of 18 years old and older who use Prettau® zirconia produced by Zirkonzahn and own:

- a Zirkonzahn CAD/CAM system produced by Zirkonzahn;
- a Zirkonzahn milling unit produced by Zirkonzahn.

Personnel from Zirkonzahn, Zirkonzahn's associated dental laboratories, business partners and speakers at conferences or events are not eligible.

Territorial scope

The competition is open to all clients/users of Prettau® zirconia produced by Zirkonzahn (the participants' personal data will be processed on a specific landing page run on an Italian server). The territorial scope is deemed the entire national territory.

How the contest works

- It is possible to enter the contest from July 9th, 2018 from 00:00 to October 31st, 2018 until 23:59.
- Participants can enter and register for the contest through a landing page specifically created for the contest and run on an Italian server. Zirkonzahn's Facebook page represents a "display page" for the visualisation of the jobs included in the contest: the participant's personal data and uploaded pictures will be collected, treated and saved exclusively on the Italian server that runs the landing page dedicated to the contest.
- During the registration, participants will be asked to fill in a digital form and provide the following personal data: name, surname, date of birth, laboratory's name (for which the participant is working and which must fulfill the above mentioned requirements), e-mail address, the Prettau® zirconia restoration's production year and the consent to the processing of personal data for the sole purpose of the competition. If some fields are not filled in with the necessary information, the participation into the contest will be cancelled. Once the registration is completed, the participant will receive an e-mail confirming his/her official participation in the contest.
- Each participant can submit only one job and can win only one prize.
- The participant can submit jobs manufactured exclusively with Prettau® zirconia produced and sold by Zirkonzahn.
- Only full-arch bridges made with Prettau® zirconia are admitted in the contest.
- Zirkonzahn reserves the right to exclude participants from the contest in case of certified violation of the above-mentioned requirements as well as the principles of fair competition.
- By registering via the landing page created specifically for this digital contest, the participant can publish a photo of his/her job and/or access the showcase gallery to cast his/her personal vote. It is possible to vote starting from the contest opening day to the closing date, which is scheduled for October 31st, 2018. Every user navigating the landing page can cast only one vote for each picture.
- The winners will be identified on December 10th, 2018 by noon, under the supervision of an official of the Chamber of Commerce of Bolzano or a notary.
- The winners will be selected by the landing page users by means of an online, telematic voting system.
- The winners will be notified in written form by e-mail and will be asked to provide additional data such as telephone number, delivery address and further personal information for the prize awarding.
- The contest will be promoted through the company's website, Facebook page, customers' e-mail contacts and company partners.
- "Backup" winners might be identified in case of failure to deliver prizes (e.g., unsolicited prizes or wrong addresses).

Nature and value of the prizes

1. A 10-day travel for two people in New Zealand organised by the Alpina Tour Dolomit travel agency (Brunico, Via Bastioni 9, 39031 – Tel. 0474 555 501). The agency will provide the winner with a 10-day travel voucher worth 5,000 euros that can be used at any time during the voucher's validity period, which starts on June 1st, 2019 and ends on May 30th, 2020.
The voucher covers flights, food, accommodation expenses as well as the costs for local transfers as organised by the travel agency. In particular, the voucher includes two roundtrip airplane tickets to and from New Zealand, accommodation in hotel for two people with breakfast included, two ferry tickets from Picton to Wellington, admittance to the "Rainbow Springs Kiwi Enc." natural park and car rental with insurance included. The voucher does not include home-airport travels, nor possible expenses related to Visa procedures. The prize recipient will be responsible for any extra costs exceeding the established budget.
2. One-week training for two people at the Forest School (one of "Die Zirkonzahn Schule" facilities located in Prettau, 39030, BZ), worth € 3,000 + VAT. The prize covers the cost of the course and training materials as well as board and lodging for the two participants. Travel expenses to reach the course location are excluded. Any local transfers will be organised and covered by Zirkonzahn.
3. 1 Apple smartphone, Iphone X model, in black color worth 1,189 € + VAT.

Delivery time

Prizes will be awarded to the winners by March 31th, 2019. Prizes will be delivered by courier service from Zirkonzahn Srl's headquarters (An der Ahr 7, Gais, 39030, BZ) to the address indicated by the participants who will be awarded with the prizes.

Information on the protection of personal data (art. 13, Legislative Decree 196/2003)

The data will not be made available to third parties. Participants in the contest can request to amend, block or delete the data at any time, or to avail themselves of other participant's rights provided for in Article 7 of the Italian Civil Code. By communicating the data, the participant authorises the data owner to treat his/her personal information for the above-mentioned purposes.

The participants shall not post pictures or deliver information that will allow the webpage users to recognise the identity of third parties who are not directly involved in contest, failing which the participation in the contest will be cancelled, with possible complaint for breaches of privacy.

By giving his/her consent to the personal data treatment, the participant automatically authorises Zirkonzahn Srl to use and share the materials uploaded for the 10 Years Prettau® Zirconia contest.
